#### 4.1 Description of first aid measures

##### General notes

Do not leave affected person unattended. Remove victim out of the danger area. Keep affected person warm, still and covered. Rinse mouth with water (only if the person is conscious). Let be drunken in little sips: 0,1-0,2l Water. Do NOT induce vomiting.
