4.1 Description of first aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. Keep affected person warm, still and covered. Remove contact lenses, if present and easy to do. Continue rinsing. Irrigate copiously with clean, fresh water for at least 10 minutes, holding the eyelids apart. In all cases of doubt, or when symptoms persist, seek medical advice.

Following ingestion

Rinse mouth with water (only if the person is conscious). Let be drunken in little sips: 0,1-0,2l Water. Do NOT induce vomiting.
